# 2 Minutes of the last meeting of 24<sup>th</sup> February

#### 3 Matters Arising

Sign-up for patient access: 235 have now signed up. Patients can now additionally signup for full records, but this needs a further security process. The PPG were reminded that as of 1st April 2016 patients also have the ability to request access to coded information contained within their medical record; this includes information such as problem headings and test results in addition to allergies, medications and immunisations. Patients requesting access to this coded data are required to complete further security checks in order for the practice to grant online access medical records.

A number of comments were made concerning the Reception TV screen, particularly about contrast issues around text over the yellow background and other related readability problems.

#### 4 PPG Development

#### 4.1 Progress with the PPG website (JH)

Jim met with the Campbell practice on 6<sup>th</sup> April, and advised the Group:

At the last joint PPG Website development meeting, the consensus of the group was that the Website was in a suitable form for wider dissemination. It was considered important that the site had suitable new material on a reasonably regular basis.

Updating the PPG page on the Practice website will be looked at by SM and pursued by the website development group. It was noted that there was a link to the PPG website on the Practice website but it was felt that this could be made more prominent.
