4.1 Targeting to Improve members' NHS understanding of Systems & Jargon

The following suggestions /questions were raised:

- I could do with an idiot's guide to some of the acronyms that are used copiously at meetings.
- much of the input and information disseminated is from folk who have attended committees, seminars, and discussions in other sub-groups and, whilst it's always interesting, those of us who haven't been involved alongside them, don't really have anything constructive to add.
- I personally don't feel particularly excluded when such items are being discussed, but maybe there could be opportunities for all PPG members, who would like to, to accompany the `lead member' at some of these groups from time to time. Thus, learning first-hand what it's all about.

- Explanation of practice relationships, team structures et cetera
- CCG, Rural Alliance What are they and where do they fit in?
- PPG why do we have one et cetera? Are there defined objectives?
- Reflection of patient views? Jim offered to guide this latter point based on his experience.

Nigel is keen to establish a training meeting to cover these types of points. It was agreed that Sue, Jim and Geoff try to meet with him to discuss detail. It will be necessary to set dates/times for such meetings (perhaps 2 dates?), ensure room available (liaising with Sam). Then to publicise meeting, and compile a list of frequently asked questions.

On a further thought, Geoff suggested that we seek Sam's help to resurrect the Staff minipresentations about their roles. This was done about four years ago. He found them useful at the time. However, some roles have subtly changed. It could help the newer staff to get to know PPG members and vice versa.

5 Issues of Current Concern to PPG Attendees

- 5.1 Marian asked if our own NHS Trust has plans to follow the policy of the Trust in Cambridge, where GP surgeries are now charged a fee by the city's hospital for each patient who attends their A & E Departments, and with conditions that should have been dealt with at GP level. If so, is there a role for PPG in helping to ensure that patients are fully aware of the implications of going to the Countess or Leighton with a non-urgent ailment? AA gave feedback on this point
- 5.2 With the recent news about Kelsall GPs' new surgery. Is there any possibility or consideration of joining up or sharing services? Agenda item for next meeting

- 5.4 Do we have/can we have a better understanding of our demographic spread in order to attract more and correct PPG members. Practice can share at next meeting
