3 Part-time nurses will be standing-in for Becky during her maternity leave.

Patient survey results: The Practice is 428<sup>th</sup> in the whole country - out 6875. In the County of Cheshire, the Practice is number 6. The PPG members expressed their congratulations on this achievement.

1<sup>st</sup> Health Watch visit had taken place in the week before last. Their report is awaited.

Improved signage leading to the correct main entrance to the surgery from car park has been requested.

Sam had a regulatory 1hr phone call last Wed 18<sup>th</sup>, responding to the 1<sup>st</sup> CQC annual review. The Practice still maintains its 'Good' rating.

## 7 Patient Suggestions/Friends and Family

Jim advised that he's seeing very similar results in the period from Jun- Aug, with 58 completed forms. There were 42 with comments.

There continue to be no adverse comments following introduction of 15-minute appointments. A useful suggestion concerned appointments for Annual visits: it would seem sensible that conducting any required blood or urine tests at the same time, instead of repeat separate visits, would be beneficial. The PPG agreed.

There are concerns that the Travel Clinic has been discontinued, but the Practice is still offering contracted level of vaccines.

There are also continuing comments regarding overhearing of reception conversations in the waiting room. Sam observed that the reception window seals have recently been improved, so needs further monitoring.

The possibilities for improving use of land in Park Road has to be left in the hands of the local Council as well as input from the Practice. Sue Dewhirst (Campbell practice Manager) is leading on this, together with Parish Council.

#### 7.3 Sign-in screen `number of patients waiting' issue

The screen design is not under direct control of the Practice, but gets updated by the system provider. As and when this is due for replacement the Practice will look at replacing it with something that is hopefully more sophisticated.
